

LEA Title I Parent Involvement Policy

In order to meet its goal of providing appropriate educational opportunities for all students in the school district, the Board shall participate in the federal Title I Program.

Title I School-Parent Involvement Activities

- 1. Notification: A letter is sent to the parents of each child participating in the Title I program. This letter explains the rationale of the program and requires that a parent's signature acknowledging their child's placement be returned to the Title I teacher.
- 2. Parent/Teacher Conference: Preceding the end of the first quarter, teachers will contact/schedule a time to get acquainted with parents.
- 3. Homework: Parents are asked to supervise their child's homework, assist if needed, and sign the homework slip to be returned the following day with the completed homework assignment.
- 4. Visits and calls: To inform parents of their child's progress or lack of progress, or if extra parental assistance for drill and practice is needed at home, calls may be made by the Title I teacher.
- 5. Compact: A Student-Parent-Teacher compact is explained and activated upon parent signature.
- 6. Progress reports: Accomplishment reports, documenting the student's progress to date, will be given to parents on a regular basis.
- 7. Resource check-out: In order to give parents/students the opportunity to further assist in their child's learning process, they may check out flash cards, games, levelled readers and various other manipulatives and supplies.
- 8. The Excelsior Springs 40 School District is required to inform you of certain information that you, according to The No Child Left Behind Act of 2001 (Public Law 107-110), have the right to know.

Upon your request, our district is required to provide to you in a timely manner, the following information:

- Whether the teacher has met state qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
- Whether the teacher is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived.
- Whether your child is provided services by paraprofessionals and, if so, their qualifications.
- What baccalaureate degree major the teacher has and any other graduate certification or degree held by the teacher, and the field of discipline of the certification.

In addition to the information that parents may request, districts must provide to each individual parent:

- Information on the achievement level of the parent's child in each of the state academic assessments as required under this part; and
- Timely notice that the parent's child has been assigned, or has been taught for four or more consecutive weeks by, a teacher who is not highly qualified.
